



APPLICATION AND OFFICIAL RULES

QUALIFICATIONS:

- All qualifying energy efficient equipment must be natural gas, and installed at a residential or commercial location of a customer receiving natural gas service from Atmos Energy, Colorado Natural Gas, Eastern Colorado Utility or SourceGas in Colorado.
- Equipment must be installed by a licensed heating or plumbing contractor, or installed by the customer at the customer address listed on the form. Low-cost measures and thermostats do not need to be installed by contractors.
- Offer is valid from January 1, 2009 until funds are depleted. All applications must be postmarked no later than 60 days after the installation.
- Qualifying furnaces and boilers must be listed on the qualifying list of devices and meet the required AFUE rating.
- Qualifying tank water heaters must have an energy factor (EF) of .62 or greater and tankless water heaters an energy factor of .82 or greater.
- Programmable thermostats must be currently Energy Star® rated. Limit two rebates per account.
- Attach a copy of all dated receipts and/or invoices that document the installation. Make sure that these receipts indicate the name, license #, address, and phone number of the contractor that completed the installation. For proper sizing, please submit a copy of a Manual J or heat load calculation.
- All receipts and/or invoices need to include equipment make, model and size to qualify for a rebate.
